

**TCSA High Power Rifle Discipline  
Bullseye Long Range Camera System  
Borrowing Agreement**

Tri-Cities Shooting Association (TCSA) Incorporated, and the TCSA High Power Rifle Discipline, P.O. Box 785, Richland, WA 99352, hereby requires that all High Power Range Safety Officers borrowing the Long Range Bullseye Camera System ID *BullseyeCam106918* read and sign this form before borrowing the camera. This is a legal document, so read it carefully before signing below.

I agree to observe and follow all Range Rules, the TCSA High Power Non-Match Use range rules found at <https://www.tcsa.info/pdfs/secure/1KYD-Non-Match-Use-Procedure.pdf>, all rules of safe handling of firearms, and all factory directions for operation of the camera. Further I agree to return the camera to the custodian on the agreed to time, in good working order, clean, and ready to check out to the next borrower after battery recharge. The unit is not weather proof, and so I agree to not use the unit in windy conditions or expose the unit to precipitation.

I agree that I will pay the cost of any and all repairs, maintenance, or shipping required due to any damage of the system while in my custody that are not covered by the factory warranty. The TCSA High Power Discipline has purchased a warranty that covers any damage to the down range unit for two years starting 11/29/2015. The warranty will replace or repair any of the Bullseye Camera Systems down range equipment (covering camera, tripod, router, booster, antenna, battery and box) if the equipment is damaged during use, even if the damage is caused by a projectile. The warranty does not cover the firing line module, and it does not cover the cost of shipping the downrange unit to the factory for repair. Further the warranty only covers damage while actually in use, not at any other time while in my custody. The warranty does not provide for a loaner unit while the unit is being repaired, so any warranty covered damage will still result in other HPRSOS not being able to borrow the unit.

I agree to pay the \$5.00 borrowing fee prior to receiving the system for each time I borrow the system.

I agree that this camera system will only be used to remotely show shots on safely operated targets at the TCSA High Power or Rose Iris Ranges. The camera system is not to be used anywhere else, or for any other purpose.

I hereby expressly release, acquit, and forever discharge the TCSA, the TCSA High Power Rifle Discipline, and their insureds, officers, successors in interest and heirs and assigns, from any and all claims, demands, damages, causes of action, attorney's fees or expenses, that I might have. I have not been influenced in any way to make this release by any representative of the TCSA. The terms of this release are contractual and not a mere recital, and express the full and complete terms of this release, and I understand its content.
