Lastly, if the heat is too much, retire to the Range House at Rose-Iris or Shotgun, they are air conditioned, for a respite if needed. Do not be afraid to ask your friendly neighborhood RSO for help if you get to the point of feeling lightheaded or faint. Better safe than sorry, we value all our members and patrons!

Other than providing shooters with a place to shoot in a safe and controlled manner, the TCSA also performs functions open to the public in several disciplines. One of these functions is to educate hundreds of our junior hunters each year through our Hunter's Education Safety Association (HESA). As we are all aware, youth are our future! Randy Absolon and his volunteers are to be commended for the work they perform for our State Hunter Education Program. For the uninformed, the HESA Range is the one just south of the Rose-Iris Public Range. This Range provides overflow duty for RSO's on days when you can't buy a bench at Rose-Iris .... & no, you cannot buy a bench (when not reserved for other functions). That is one of the perks of becoming a Range Safety Officer (preferred seating in the "Back Room").

## **TCSA FACILITIES**

**ROSE-IRIS RANGE** – A 100-yard range with 20 covered firing points. This day use Range Safety Officer supervised facility is operated for public use on a regularly scheduled basis Wednesdays, Fridays, Saturdays and Sundays.

**RIMFIRE PLINKING RANGE –** A 50-yard 22-caliber Range Safety Officer supervised Shooting Range with reactive targets.

**CENTERFIRE PLINKING RANGE** – A 50-yard handgun pistol/revolver RSO supervised range with reactive targets for firearms using black powder or standard pistol cartridges.

**COWBOY / PRACTICAL PISTOL BAYS** – Ranges consisting of 13 bays of varying lengths designed to support a variety of action shooting disciplines such as; Practical (IPSC/ USPSA) 3-Gun Sports and Cowboy (SASS) groups.

**1000-YARD, HIGH-POWER RANGE** – A Range consisting of 100, 200, 300, 600, 800, 900 & 1000-yard firing lines that can support 20 firing stations on each firing line (utilizes manned target operation). The 400-yard line has 5 firing stations and the 500-yard line has 10 firing stations. This Range supports High-Power Rifle, Long Range PALMA and Precision Shooting Events of various disciplines, including 50-Caliber.

**HUNTER EDUCATION RANGE:** This Range has been designed to support Hunter Education Training Classes and also has a practical field exercise area containing obstacles hunters could expect to encounter in the field. The covered firing line can be used independently by current RSO's as an overflow from the Rose-Iris Range and may be available for RSO supervised public event use when not being used for the conduct of Hunter Education Classes.

**PRIMITIVE USE RANGE**: - A Range Area for muzzle loading and primitive Sagebrush Free Trappers reenactment events with parking, staging and various range areas.

### HUNTER EDUCATION AND SAFETY ASSOCIATION

Good news, we are going to be able to hold **Classes this Fall**. WDFW expects to have everything set up for us to start offering Classes the weekend of **August 14 - 15**.



We are planning to offer evaluations for students who have completed the **Online Course** on **August 14**, **September 25** and **October 2**. To meet the guidelines we have to follow, class size will be limited to 15 students.

I had hoped to have more clarity by the time I wrote this article, but right now I am not sure how we are going to do the registration. When that gets finalized, the information will be posted on the **Hunter Education page** of the WDFW website.

Hunting seasons are right around the corner, so make sure you make plans for completing **Hunter Education** if you need it. **In Washington, that means anyone born after January 1, 1972**. If you are planning on hunting out of state, make sure you check the rules for that state, one state (Colorado) requires Hunter Ed for anyone born after January 1, 1949.

Students who are age 9 or older can still complete the entire course through the Online process. Younger students will have to complete the field exercise in person.

RSOs using the HESA Range are expected to sign in at the Rose-Iris Range before going over to the HESA Range to shoot. You are also expected to clean up after you are done shooting, including returning target stands to the Rose-Iris Range House and picking up all brass.

Always remember to control the direction of your muzzle, be sure of your target and what lies beyond it, keep your finger off the trigger until you are ready to shoot and never use a firearm unless you are familiar with how it works.

### ADVANTAGES OF BEING A RANGE SAFETY OFFICER

The advantages of being a RSO and obligating yourself as a volunteer at TCSA means that on days when the Range is not open to the general public -YOU - as a RSO can use the Range. Having gone through the RSO Training Class and volunteering your time you are able to go to the Range any time you like!

To become an RSO, you must be a **current member**, attend the RSO Training Class and obligate yourself to volunteer at the Range three to four times a year.

### **HIGH-POWER**

Despite the heat we are charging through the Summer with Smallbore Matches on the 3, 8, 10, 12, 15, 17, 21 and 24; Service Rifle Practice on the 3, 10, 17, 24 and 31 and a Service Rifle (RMC) Match on the 28th; a 500 Yard Prone Slow Fire Match on the 20th; Long-Range Practice on the13th and Long-Range F-Class Points Series Match on the 14th. Our full 2021 Match Schedule, Match Director contact, and Match Programs are posted on our High-Power web page at https://www.tcsahighpower.org/.

#### RANGE CLOSURES or MATCH REVISIONS: None

The following COVID adjustments to Match Operations will remain in place for the 2021 Match season:

- Social distancing is encouraged and will be maintained to the extent possible.
- If you have been vaccinated you don't need to wear a mask; no verification of vaccination is required.
- As a general courtesy, try to bring exact match fees and your own writing instruments / tablets.
- State and County guidelines will be followed.

**RANGE CONDITIONS:** The Range remains in good shape, but please use common sense and keep your speed down, particularly on the corners. **Drive only on the graveled areas and avoid any activities that may cause a fire. Report all fires immediately!** 



**HIGH-POWER RSO ENDORSEMENT:** For any interested TCSA RSO, the 1KYD High Power Endorsement Training is currently being scheduled on an asneeded basis. It only takes an hour, and allows you unrestricted access to the High-Power Range outside our scheduled Matches. The only prerequisite is that you be a current TCSA RSO.
