## TCSA FACILITIES

**ROSE-IRIS RANGE** – A 100-yard range with 20 covered firing points. This day use Range Safety Officer supervised facility is operated for public use on a regularly scheduled basis Wednesdays, Fridays, Saturdays and Sundays.

**RIMFIRE PLINKING RANGE** – A 50-yard 22-caliber Range Safety Officer supervised Shooting Range with reactive targets.

**CENTERFIRE PLINKING RANGE** – A 50-yard handgun pistol/revolver RSO supervised range with reactive targets for firearms using black powder or standard pistol cartridges.

**COWBOY / PRACTICAL PISTOL BAYS** – Ranges consisting of 13 bays of varying lengths designed to support a variety of action shooting disciplines such as; Practical (IPSC/ USPSA) 3-Gun Sports and Cowboy (SASS) groups.

**1000-YARD, HIGH-POWER RANGE** – A Range consisting of 100, 200, 300, 600, 800, 900 & 1000-yard firing lines that can support 20 firing stations on each firing line (utilizes manned target operation). The 400-yard line has 5 firing stations and the 500-yard line has 10 firing stations. This Range supports High-Power Rifle, Long Range PALMA and Precision Shooting

**HUNTER EDUCATION RANGE:** This Range has been designed to support Hunter Education Training Classes and also has a practical field exercise area containing obstacles hunters could expect to encounter in the field. The covered firing line can be used independently by current RSO's as an overflow from the Rose-Iris Range and may be available for RSO supervised public event use when not being used for the conduct of Hunter Education Classes.

## HUNTER EDUCATION AND SAFETY ASSOCIATION

We have two more evaluations for students who have completed the Online portion of the Class scheduled for this



year. The first of these will be held on **September 9**. Registration has been open for less than a week and this class is already full. Registration for the Class to be held on **September 30** will open on **September 1** and I expect that Class to fill up quickly also.

Students who have waited until Fall to complete the Field Course/Written Test portion of the Evaluation should be prepared to travel farther to finish the course. I want to point out that there were eight available seats in our **August 12** Evaluation.

Information on our Classes and all other Hunter Education Classes available across the state is available on the WDFW website.

RSOs using the HESA Range are expected to sign in at the Rose-Iris Range before going over to the HESA range to shoot. You are also expected to clean up when you are done shooting, including returning target stands to the Rose-Iris Range House and picking up brass.

Always remember to treat every firearm as if it was loaded, control the direction of your muzzle, be sure of your target and what lies beyond it, keep your finger off the trigger until you are ready to shoot and always check every cartridge to make sure it is the correct ammunition for your firearm.

## SHOTGUN REPORT

Welcome to September everyone! Seems a little strange to be thinking about Labor Day weekend already. This year is flying past, so if you want to be a high-volume shooter at the Shotgun Range, you better get to it.

September may bring the end of summer, but it also brings the **Annual Shotgun Board Meeting**. That's right, save the date and mark your calendars for **6:30 p.m.** on **SEPTEMBER 6** at the **SHOTGUN RANGE**. I'm sure there will be a host of things to discuss, so please plan on joining us.

See something, say something. Helping to keep the Shotgun Range a safe place to shoot is on all of us. We had a situation a few months back that was unsafe and I wanted to take a moment to address some of the items that have come up in the subsequent discussions and meetings.

Shotguns should always have their action open and empty until you are on station and it is your turn to shoot. Over-Unders should be broke open and semi-autos should have the slide locked back.

The only safe direction to point a shotgun is down range. Period. No matter if it is pointed at the ground or not, you need to be facing down range.

If you are shooting Station 8 on Skeet, you only load one shell at a time. No exceptions. You are changing stations when you move from the high house to the low house shot. We do not move off of a station with a loaded and/or a closed shotgun.

If you have a failure to fire, whether it is due to a malfunction of the shotgun or the ammo, always keep the gun pointing down range in a safe direction.

The above are just a few things to keep in mind while you're out shooting or observing other people shoot. If you shoot long enough, you are going to see something, say something or most likely both.

One final thing before I wrap up my TED talk on safety. A very seasoned shooter said something to me when I asked his advice on a safety situation and it made a lot of sense. Sometimes we are wrong. We do something that we perceived as safe that was indeed not. And when we are confronted with this issue, we can get defensive or indignant when we should really just accept the fact that we made a mistake, learn from it, apologize, and move on. The other side of that is how we approach people who are being unsafe. Yes, the severity of the safety issue can affect how animated we get, but we should always strive to educate people rather than berate them.

Now we go from an important issue to one that bums me out. **Ken Mikkelsen** passed away on April 27<sup>th</sup>. Ken was always a fun guy to talk to and would help out where he could at the Range. While I cannot say I ever shot a round of skeet with Ken, we did shoot the breeze quite a bit. When I was reading Kens obituary, I thought it was funny that it says he was born in the "small village" of Richland, Washington. For some reason that fits my image of him, Godspeed Ken.

Ok, we will move onto more cheery things now. It has come to my attention that attaining the title of "Hero Volunteer of the Month" is something many are striving for. ## **HIGH-POWER**

With the end of August, it is time to look forward to cooler temperatures and hunting season is right around the corner. For those of you High-Power RSOs who plan to come to the Range to test out your hunting rifles at longer yardages, a few points to remember:

(1) if you are headed out check the calendar first: https://www.tcsahighpower.org/\_files/ugd/e01b6a\_f25ab189 3e1f4668a378da3dc6085ca1.pdf

Note that the September 9 OAR Match is cancelled, that gives you 3 weekend days in September with nothing scheduled on September 2, 3 and 9 plus Labor Day September 4.

- (2) if you have not been out to the Range since last year, I will hit the high points of High-Power specific procedures for you. Do not forget to put up the Bravo flag near the main gate when you arrive. If it is already up, someone is there ahead of you. Before heading to the pits remember to check the 800 1000-yard firing lines to make sure someone isn't already there shooting long range. Remember to sign in at the pit connex (west end) and to pay your daily use fee as well. Remember all shooters present must shoot the same yardage. You cannot use the 500-yard firing line while someone else is using 600 for example.
- (3) if you have guests, just like down at Rose-Iris you should spend a few minutes going over the rules before the firearms come out of the rig.
- (4) if you do not have a good idea of the come up for your load at longer yardages, start at shorter range and work your way out. We want to make sure all the bullets are in the berm!
- (5) all standard safety rules still apply, keep those muzzles in a safe direction etc.
- (6) use the stairs if you need to go down the face of the firing berm to retrieve brass. Do not erode the fill walking down the face unnecessarily.

If you still need to get **your work day in for the year**, contact **John Julian**. We will likely be needing help for the State Service Rifle Championship on September 23 - 24.

Looking ahead at the September calendar, on the Centerfire side we've got a Long Range V2 Points Series Match on September 16. On the 23<sup>rd</sup> and 24<sup>th</sup> we've got the State Service Rifle Championship and a CMP EIC Match. This one is a great opportunity to earn leg points for CMP and the state award. The wind is often a factor in who wins this match, so come prepared! On the 26<sup>th</sup> we've got a 200/300 Yard Match and we round out the month with 50 BMG Matches September 28 - 30. Note again the 500 OAR Match on the 9<sup>th</sup> is cancelled.

On the smallbore side, we've got a **Dewar 50/100** on the **5**<sup>th</sup>, **Vintage Smallbore** on the **7**<sup>th</sup>, a **100/200 Smallbore** and **ELR Smallbore** on the **10**<sup>th</sup>, **50 Yard Benchrest** on the **12**<sup>th</sup>, **50 Yard ARA Smallbore** on the **14**<sup>th</sup> and a **100 Yard Mini Palma** with club provided ammo on the **17**<sup>th</sup>. The Mini-Palma on the 19<sup>th</sup> is also cancelled.

Looking back at August, we had a **50/100 Dewar** where ten folks showed up to enjoy the early cool temperature and low velocity winds. **Ben Cook** and **Tom Halecki** both shot "cleans" at 50 yards. Ben was Match winner closely followed by one point by Tom. Ben had the high X count of 29 which is a great demonstration of marksmanship. **Brandon Tinker** and **John Schneider** tied numerically for 3rd and 4th but Brandon's X count was greater than John's. Our only Junior shooter, **Cameron Tinker**, was keeping his Dad honest and shot a very competitive score at 94.25%.

We had a Vintage Small Bore on August 3, the winds were very light and the early start allowed avoiding most of the heat. The top four shooters all shot "Match Cleans" so the placement became a battle of the X's. Glen Buxton was crowned "Match Winner" with 33 X's. Congratulations Glen! Tom Halecki, Gary Meerdink and Ron Jorgensen were right behind with 31, 30 and 29 X's. Not much spread there. The High Card was taken by Brandon Tinker using iron sights. Congratulations Brandon! Brandon, Cameron Tinker and Rob Ellis all shot with iron sights and yielded some really competitive scores. There are only three scheduled Vintage Smallbore matches remaining in 2023.

Next up was a 50-Yard Smallbore Benchrest on August 8. It was a pleasure to spend some time in the nice weather with a talented bunch of riflemen. The Match was well attended and I hope you all enjoyed each other's company and the cooler weather. **Ben Cook** (The Penultimate Wind Master) sure showed his exceptional skills despite having little wind to play with. Ben scored the high card and was also Match Winner. Way-to-Go Ben! **John Schneider** had the high X count. Big thanks to **Tex Long** for running the shooting line and helping with scoring.

August 10 was an ARA Smallbore Match, it was a pretty breathless day for card 1. The wind started picking up for card 2. As usual **Tom Halecki** was consistent and accurate winning both the aggregate score and high card. Great job Tom! **Gary Meerdink** had a great performance as well. **Ron Jorgensen** and **Kaleb Harvey** fought it out for 3<sup>rd</sup> and 4<sup>th</sup> place.

Now on to some centerfire results, August 22 was a 200/300 Yard Match. The weather looked really "iffy" when we first arrived but the front held off and we were able to shoot. The rain knocked most of the smoke out of the air and it was windy but consistent. A BIG thanks to Larry Meerdink for helping run the match! Tom Halecki shot a "clean" at 200 and was Match Winner today. Congratulations Tom! Gary Meerdink followed Tom by one point and had the high X count. Thanks to Dave McCauley, Tom and Larry for helping with the range equipment and targets.

The August 26<sup>th</sup> Regional Match Course was lightly attended as is common for the August match each year. Those present were rewarded with an excellent day to work on wind calling and shooting offhand while in gusts big enough to move your sights to the next target. **Dave Baalman** was the overall winner with a score that was not one for the record books. I was just happy to have them all land in the scoring rings!

Finally, the August 27 Mini-Palma had great conditions. Only four shooters turned out but those four had a good day. Very little wind but each relay got caught by a wind shift. Two shooters shot a clean 150 for the simulated 800-yard target. The match winner was **Brandon Tinker** with a 448 and 23 x's. Thanks to **Ron Jorgensen** and **Ben Cook** for running the match.
