## MEMBERSHIP CLASSIFICATIONS

**Membership Fees:** Persons purchasing TCSA Annual memberships will pay a full-year membership fee when joining; regardless of which month they join. All annual memberships expire each April unless renewed.

**Annual TCSA memberships:** **The Annual TCSA Membership Year is from Apr 1<sup>st</sup> to Mar 31<sup>st</sup>**

**Adult Membership:** Any person 18 years of age or older. **\$50/year**

**Spousal/Couple Membership:** Two Adults (spouses) 18 years of age or older. Both members will receive Membership cards bearing the same number but with different alpha designators (A, B, C, etc.) **\$75/year**

**Junior Members:** There is no charge for children 17 years of age or younger to shoot at our range. **However**, children 17 years of age or younger who want to be an actual junior member with a membership card may be sponsored by an Adult, Spousal or Life Members. The junior member(s) will receive a membership card with the same number as the sponsoring adult. Children are required to be accompanied and supervised at the range by their parent or sponsoring adult. Non-shooting adults accompanying children to the range are not required to pay the **day use fee. \$10/year for each junior member sponsored**

### Annual membership renewals:

TCSA Members 1<sup>st</sup> annual renewal fee will be based upon when they actually joined the TCSA as follows, but all future annual renewals will be at the established annual rates approved by the TCSA.

**If they joined between January 1<sup>st</sup> through Sept. 30<sup>th</sup>** they will be billed a full-year's membership renewal fee. **Adult \$50/year; Spousal \$75/Year; Junior Membership; \$10/year for each junior sponsored.**

**If they joined between October 1<sup>st</sup> through December 31<sup>st</sup>** their second year membership renewal fee will be pro-rated to 60% of a full year membership: **Adult \$30; Spousal \$45**

### Non-expiring Memberships

**Life Membership:** Individuals 18 years of age or older who purchase a Life Membership have the privilege of participating in any scheduled shooting activity at any TCSA Range at member rates for as long as that individual lives. Life Members who have completed the TCSA Range Safety Officer Class are provided the gate access card and have the privilege of utilizing the Rose-Iris Range on any day. Life members are exempt from Range Safety Officer duty days. They may also use any other TCSA Ranges when they have completed that range's basic knowledge and safety requirements training. Life Members will receive a new Life Membership Card each year they submit an updated membership form. They have the privilege of bringing one non-paying guest with them to any range or scheduled range activity, and that guest may also participate on that range at the current member rates, subject to that Range's target fees. - **\$1000 onetime fee**

**Endowment Member** - See Life Membership description above - **\$1500 onetime fee**

**Patron Member** - See Life Membership description above - **\$2500 onetime fee**

**Benefactor Member** - See Life Membership description above - **\$5000 onetime fee**

**Military & Law Enforcement Personnel:** Active Duty Military Personnel, Reservists, National Guard Members, Retired Military Personnel with a Military ID Card or Retired ID Card, and Law Enforcement Officers showing their Officer ID or ID & Badge are invited to utilize TCSA range facilities as our guests requiring no payment of day use fees at the Rose-Iris Range and payment member fee rates at the discipline ranges including any target fees incidental to specific discipline ranges that may be charged.

**Members who have not renewed their membership by April 30<sup>th</sup> will be required to renew before being permitted to shoot at any of the ranges without paying the Day Use fee.**
